**CAMPAIGN FINANCE AND PUBLIC DISCLOSURE BOARD ISSUES FINAL PUBLIC SUBSIDY  
PAYMENTS TO QUALIFYING CANDIDATES IN 2006 ELECTIONS**

The Campaign Finance and Public Disclosure Board distributed \$4,799,603 in public subsidy payments to 381 candidates running for state constitutional and legislative office in 2006. The 381 candidates who received a public subsidy payment represent 90.5 % of the 421 candidates who were nominated at the September 12, 2006, primary election. A list of qualifying candidates and payments is attached to this news release.

Public subsidy payments are made from the General Account and the Party Accounts of the State Elections Campaign Fund. Money is allocated to the Fund based on taxpayer checkoffs on state tax returns. The Fund is also supplemented by an appropriation of \$1,120,000 per general election from the general fund of the state.

The General Account is allocated between offices on a statutory formula and the amount available for each office is then divided by the number of candidates qualifying for the payment. Green Party candidates do not qualify for general account payments because of their minor party status. Green Party candidates were eligible to receive party account payments.

Payments made from the State Elections Campaign Fund were based on Department of Revenue processing of 99.7% of tax returns. Constitutional Office and Senate candidate payments are based on checkoffs on state tax returns for tax years 2002 through 2005, while House candidate payments are based on returns for tax years 2004 and 2005.

To be eligible to participate in the public subsidy programs, a candidate must sign and file a Public Subsidy Agreement with the Board in which the candidate agrees to abide by statutory campaign expenditure limits and agrees to limit contributions by the candidate to the candidate's principal campaign committee. A candidate must also raise a specified amount in individual contributions and file an affidavit stating that this requirement has been met.

Of the 455 candidates who filed for a state constitutional or legislative seat in July of 2006, 440 (or 96.7%) voluntarily signed the public subsidy agreements to abide by spending limits and other conditions of the agreement required under the state Ethics in Government Act.

A candidate who is unopposed in both the primary and general elections may not receive public subsidy. Any amount from a Party Account which would have otherwise been available to an unopposed candidate is paid to the candidate's political party. A total of \$17,941 will be paid to the Republican Party for three unopposed candidates, and \$13,381 will be paid to the Democratic Farmer Labor Party for four unopposed candidates.
